ven in 2021, the subject of "Financial Planning "continues to be misunderstood. Some people think that a Financial Plan and an Investment Plan are the same thing – while others think that a Financial Plan is a retirement projection that took someone 30 minutes to produce.

WHAT IS A FINANCIAL PLAN?

In the past (within our industry *and* in the eyes of the general public), a Financial Plan was often considered to be synonymous with an Investment Plan. This is, quite simply: **FALSE.**

In the way that flossing is just *one* element of a comprehensive oral health plan, your Investment Strategy is just *one* of many aspects that should be built into your overarching Financial Plan.

A truly holistic Financial Plan includes:

- A Comprehensive Cashflow Analysis
- Financial Management (net worth and cash flow)
- Insurance + Risk Management
- Tax Planning
- Retirement Planning
- Estate Planning + Legal Aspects
- and Investment Planning too!

The key is to bring all these moving parts together, and build a streamlined Financial Plan that works like a well-oiled machine to help you reach your goal(s), faster.

Many Dentists use a variety of professionals who separately manage each of the pinpointed areas above, in the confines of their own silos. It is then up to the Dentist to pull information together from all these different sources, and act as the "go between."

WHAT IS THE DIFFERENCE BETWEEN INTERFACING VS. INTEGRATION?

The difference between Interfacing and Integration is very straightforward.

With interfacing, data is stored and maintained in multiple locations – which requires more administration (a.k.a. the expenditure of *your* precious minutes and hours) in order to "pull things together."

Integration indicates an efficient system, where all the services, products or professionals are "one." Or in our case – working closely together on a consistent basis, keeping all your data in one place, and managing all the moving parts of your professional (and personal) finances through ONE point of contact.
